ORDER

Whereas, Delhi Nagrik Sehkari Bank Limited, Regd. Office: 720, Near Ghanta Ghar, Subzi Mandi, Delhi-110007 (hereinafter referred to as 'Bank'), is registered with this department under the provisions of Delhi Cooperative Societies Act, 2003 (hereinafter referred to as 'Act') and rules framed thereunder,

Whereas, Chief Executive Officer of the Bank has informed vide letter dated 27/06/2024, that the last election of the society was held on 17/10/2021 and the term of the existing Managing Committee is expiring on 16/10/2024. Accordingly, Sh. Shri. Bajranj Lal, DANICS (Refd.), was appointed as Returning Officer to , conduct the election for the Constitution of the new Managing Committee.

Whereas, Sh. Bajrang Lal, DANICS (Retd.) vide letter dated 24.09.2024 has resigned from the post of Returning Officer, Delhi Nagrik Sehkari Bank Ltd.

And whereas, Hon'ble High Court of Delhi vide order dated 27.09.2024 has observed that Sh. Bajrang Lal is not willing to continue as Returning Officer and directed that the RCS shall appoint a new Returning Officer on 30th September, 2024 and new Returning Officer shall continue with the election process from the stage where Mr. Bajrang Lal left. The new Returning Officer shall coordinate with Mr. Bajrang Lal to take over records as well as lock and key if any available with Mr. Bajrang Lal.

And whereas, in view of the averments made in the resignation letter of Mr. Bajrang Lal, Mr. Justice Kailash Gambhir (Retd.) has been appointed as an observer. The fees of the observer is fixed at Rs. 2 Lakhs by the Hon'ble High Court of Delhi-

Now therefore, I, Surinder Narang, Assistant Registrar (Banking) O/o RCS, hereby convey the approval of the Competent Authority to appoint Shri Sanjay Sharma, Deputy Secretary, Ministry of Home Affairs, Govt. of India as Returning Officer in Delhi Nagrik Sehkari Bank Limited, under section 35(1) of DCS Analis, Govi. or more as treturning Chice in Beauty agent of the society's Act, 2003 with remuneration of Rs. 10,000/- (Rupees Ten Thousand Only/-) consolidated from the society's fund plus travelling allowance from the society's fund. The Returning Officer shall complete the election process as directed by the Hon'ble High Court of Delhi.

The other expenses of the election will be met out from the fund of the society. The election of Managing Committee of the aforesaid society shall be conducted as per the provisions of the DCS Act, 2003 and rules framed thereunder.
